This Memorandum of Understanding (MOU) is executed on 20th March 2023

BY AND BETWEEN

ASD Government Degree College for Women(A), Kakinada (henceforth referred as ASDGDC (W)(A)), established on 2nd October 1962 and affiliated to Adikavi Nannaya University, located at Jagannapet, Kakinada-533002, represented by Principal Dr.V.Anantha Lakshmi, hereinafter referred to as First Party,

AND

D.E.I. INFORMATION CENTER, Kakinada an Information/Examination center of Dayalbagh Educational Institute (Deemed to be University) Dayalbagh, Agra 282005, represented by Center Incharge, Smt. V.Suryakantham, hereinafter referred to as Second Party.

WHEREAS

ONE PARTY

A S D Government Degree College for women (Autonomous), Kakinada (hereinafter referred to as ASDGDC (W)(A)) aims to offer quality education for the girl students. The college has been serving the need of higher education and it is fulfilling the multiple aspirations of women students from socially and economically deprived sections of the East Godavari district. It has a campus area of 7.2 acres and a student strength of nearly 1200 students offering 14 UG courses in B.A, B.Com and B.Sc and 2 PG courses. The college was conferred autonomous status in 2015-16 recognising the excellent services offered to the students.

SECOND PARTY

D.E.I. INFORMATION CENTER, KAKINADA an Information/Examination Center of Dayalbagh Educational Institute (Deemed to be University) Dayalbagh Agra notified as such vide number F0-3-78AU-3DATED 16TH MAY 1981, Ministry of Education and Culture, Government of India and notification number OEC/Univ/State/07/5522 dated 31st August 2007 DECIGNOU situated at Dayalbagh Agra having its Information and Examination Center at Kakinada

A. Both parties realize that Education is fundamental for achieving full human potential, developing an equitable and just, society, and promoting national development. They also realize that providing universal access to quality education is the key to India's continued ascent, and leadership on the Global Stage in terms of economic growth, social justice and equality, scientific advancement, national integration, and cultural preservation.

B. ASDGDC(W)(A) and Dayalbagh Educational Institute (Deemed to be University) Dayalbagh, Agra have decided to collaborate and partner to bring convergence of Higher Education and Skill Development by imparting skill development to the final year and other students of ASDGDC(W)(A) with a Special focus to improve their employability skills inline with the New National Education Policy 2020 (NEP 2020). The proposed Skill Development Programme envisions in providing the students a platform to acquire industry specific skills while pursuing their formal education.

NOW THIS MEMORANDUM OF UNDERSTANDING, WITNESSETH AND IT IS HERE BY AGREED AND CONFIRMED BY AND BETWEEN THE PARTIES HERE TO AGREE AS FOLLOWS:

Article-1

GENERAL

1. The parties have entered into this Agreement to set out the commitment and establish responsibilities of each party towards implementation of skill development programme to the final year and other students of ASDGDC(W)(A), Kakinada.

2. Project Objective: It has been the concern of both the parties to develop the human resources by way of imparting vocational training as per the existing demand of the Industry and create avenues for suitable livelihoods and expanding universe of knowledge to produce skilled workforce.



3. DEI INFORMATION CENTER - KAKINADA Information/Examination Center of Dayalbagh Educational Institute (Deemed to be University) Dayalbagh Agra have decided to collaborate in implementing several skills of Textile Designing and Printing consisting of Block Printing, Tie and Dye and Screen Printing Internship to the final year and other students of ASDGDC(W)(A) to improve their employability skills.

4. Periodic meetings shall be conducted between the representatives of ASDGDC(W)(A) and D.E.I. INFORMATION CENTER , KAKINADA, Dayalbagh Educational Institute(Deemed to be University) Dayalbagh, Agra to concerns, if any, during the programmes shall be brought to the notice of Coordinator DEI Distance Education, Dayalbagh, Agra and Coordinator DEI Textile Design & Printing, Dayalbagh, Agra.

5. In pursuance thereof, the parties have agreed to enter into this Agreement

6. Effective Date: This MOU is effective from 20th March' 2023

7. Validity: The tenure of this Agreement (effective date), is three years from the date of signing of The Agreement (effective date), and valid upto 20th March' 2026 subject to the enhancement of fees from time to time by the University. The MOU shall be extendable for a further period of two Years by mutual consent and subject to further extension for such period or periods as may be mutually agreed to by the parties.

8. Exit: In case either of parties propose to exit from the MoU, they shall do so by giving a 60 days written notice in advance to such termination/exit, inform their intention to exit. The parties shall mutually discuss and agree up on further course of action to be taken, within 3months from the date of issue of the exit notice. Any such request shall be discussed among the parties mutually before allowing either party to exit from the MoU. And as for the case of early termination, parties shall settle all the dues liable to each other

Article-2

RIGHTS & OBLIGATIONS OF PARTIES

1. Roles & Responsibilities of FIRST PARTY ASDGDC(W)(A)

i) ASDGDC(W)(A) shall identify the eligible final year students and propose the final list to D.E.I. INFORMATION CENTER , KAKINADA Information/Examination Center of Dayalbagh Educational Institute (Deemed to be University) Dayalbagh Agra, so that Dayalbagh Educational Institute (Deemed to be University) Dayalbagh Agra can assess their suitability and enroll the students to the 3 months Internship. The final list of enrolled students shall be certified by ASDGDC(W)(A).

ii) ASDGDC(W)(A) will assume the role of collaborative partner and extend its complete support in making the proposed 3months Internship a big success.

- (c) Mrs. M. Bhaskara Lakshmi, Head, Department of English to take care of all academic requirements, conduct of the programme, functioning of the institution of ASDGDC(W)(A).
- d) ASDGDC(W)(A) to pay training fee to DEI INFORMATION CENTER ,KAKINADA which will be deposited to DEI Agra, in accordance with the provisions of this agreement(MOU).
- e) ASDGDC(W)(A) shall pay Rs 5000/- (five thousand rupees) per student as fees and other emoluments at the time of commencement of the course. However, the fee and other emoluments can be paid in 3 direct instalments first month Rs 2000/- second months Rs 1500/- and third month Rs 1500/-.

2. ROLES AND RESPONSIBILITIES OF 2nd PARTY- D.E.I.

- a) DEI is the training partner which shall be training minimum 20 final year degree students of ASD Government Degree College for Women (A), KAKINADA, the first phase (May 2023 onwards) and the strength can be increased in mutual consultation with D.E.I. INFORMATION CENTER , KAKINADA.
- b) DEI is responsible for deploying the trainers and other resources as required to deliver the proposed 3 months Internship for the final year and other students of ASDGDC(W)(A) at the campus of DEI Information/Examination Center , KAKINADA, Faculty appointments will be finalized by DEI, Agra as per rules and usual practice. The Center - in-charge, will be responsible to see administrative work of running of the training which shall be classroom (offline) to be conducted at DEI Campus, KAKINADA.
- c) DEI Dayalbagh, Agra, shall issue the 540 hrs certificate of completion to all the qualified students of the programme based on the final assessment.
- d) Mrs. M.Bhaskara Lakshmi ,Course Coordinator, DEI Information Center , KAKINADA, to ensure successful conduct of the Course from time to time on behalf of DEI,Agra.
- e) The examinations and evaluations both internal and external will be conducted by D.E.I. INFORMATION CENTER , KAKINADA of DEI as per norms and systems of DEI University examination system and Syllabus is also prescribed as per the University guidelines and the 3 courses will be completed in 540 hours (180 hours per month)

Article-3

OTHER CONDITIONS

1. This Agreement is legally binding on the parties hereto.
2. This Agreement shall be governed by the Laws of India.
3. This Agreement may be modified or amended only by written agreement among the parties.
4. Any dispute or difference arising between the Parties, which cannot be mutually and amicably settled by the Parties within 60 (sixty) days thereof, shall be referred to the Heads of the Parties, who shall then resolve it amicably. The parties shall try to settle amicably through direct negotiations, any dispute, controversy or claim arising out of or relating to the present

dispute, or lack of such and termination of the Agreement. In the event, the dispute cannot be resolved amicably within the thirty days of the commencement of the trial court process or such further period as may be mutually agreed by the parties, then the dispute will be referred through the Arbitration and Conciliation Act, 1996. Dispute of Arbitration shall be of KAKINADA and the matter shall be referred to a sole Arbitrator appointed by both the parties and the proceedings shall be conducted in English. Only the court of KAKINADA shall have the jurisdiction to adjudicate the dispute, if any, arising out of or about this Agreement.

5. THIS MOU SHALL BE SUBJECT TO THE EXCLUSIVE JURISDICTION OF KAKINADA COURT.

This Agreement is executed in counter-parts, each of which shall be deemed to be original and retained by each of the Parties but together they shall constitute one and the same Agreement.
