

In the reference 1st cited Government has issued certain guidelines regarding the importance, functioning and appointment of staff in Autonomous colleges and issued certain instructions. Among other things the following are the requirements while selecting the Teaching staff for Autonomous Colleges.

The Lecturer shall be appointed through screening on the basis of the following criteria:

- Ph.D/ M.Phil(in order of preference)
- Aptitude for innovation and academic excellence
- Must be drawing UGC pay. If such lecturers are not available or not willing, then lecturers drawing other scales may be posted.
- Must possess a minimum service of two years as lecturer.
- The tenure may be five years subject to performance.

All Lecturers working in Government Degree Colleges in the State were issued necessary instructions in connection with the selection process in 9 Autonomous Colleges in the state as per the said G.O.

In response to CCE's instructions certain lecturers working in Government Degree Colleges have submitted their applications for appointment as Lecturers in Autonomous Colleges vide reference 2nd read above.

Accordingly, the Selection Committee met and conducted interviews on 27.5.2015 to 29.5.2015 & 23.8.2015 and recommended their candidature for postings and transfer to Government Autonomous Colleges in the State.

In pursuance of Government orders 3rd, 4th & 5th read above and recommendations of Selection Committee Sri/Smt/Dr. ARUNA KOPURI Lecturer in Microbiology, GDC (SCIM) TANUKU, West Godavari district is hereby transferred at his/her request and posted as lecturer in Microbiology, GDC (ASD) (W) KAKINADA, East Godavari district in place of T Sony, Lecturer in Microbiology with immediate effect.



The Lecturer under orders of transfer is informed that he/she is not entitled for any TTA as transfer is at his/her request.

The Principal, GDC (SCIM) TANUKU, West Godavari district is requested to relieve the said lecturer at once without waiting for a substitute with instructions to join at the new station forthwith and report compliance. Therefore, in continuation of the above para, he/she is further informed that the promotion (recruitment by transfer) as Lecturer of Government Degree College is subject to the out come of the O.As / Writ Petitions pending before the Hon'ble A.P.Administrative Tribunal and Hon'ble High Court of A.P., Hyderabad, related to the issue of eligibility by possessing the educational qualifications prescribed as per UGC Regulations, 2009 followed by Government of A.P. vide reference 9th above which is yet to be finally adjudicated by Hon'ble High Court as per reference 5th above. Therefore depending on the final outcome of said legal issue, the services of the temporarily promoted Junior Lecturer may be liable for reversion if and when such a legal eventuality arises on account of final disposal thereof by the competent Judicial Authority.

The individual is not entitled for any T.T.A., and joining time etc., as his/her posting on promotion is ordered at request.

The Junior Lecturer now promoted is informed that his/her services as Lecturer are purely temporary and liable to be terminated at any time without any notice and without assigning any reason what so ever for such termination. He/She is also informed that his/her appointment as Lecturer is ordered without prejudice to the claims of other senior lecturers if any, in the subject in the zone.

The Junior Lecturer under orders of appointment as Lecturer to Government Degree College is informed that as per Rule 11 (b) of A.P.State and Subordinate Service Rules, 1996, he/ she should join duty at the place of posting within 15 days from the date of receipt of these orders without fail, failing which, he / she will forego his / her right of appointment as Lecturer both for the present and future.

The Principals of Government Junior / Degree Colleges concerned are categorically instructed to verify the original Certificates of Educational qualifications and also the Caste Certificates in respect of SC / ST candidates before they are relieved from duty and admitted to duty. Any discrepancy in this regard should be brought to the notice of the Commissioner of Collegiate Education immediately. The Principal will be personally held liable for any lapse.

The Principal of Government Junior College (B)Jaggampeta, East Godavari District is requested to relieve the individual at once with instructions to join duty in his/her new post within the stipulated period of time. If the individual is not willing to accept the promotion as Lecturer of Government Degree College, a declaration may be obtained from him/her declining the promotion and send it to the Commissioner of Collegiate Education immediately.


