REPORT ON SKILL HUB INITIATIVE

The college submitted a proposal for initiation of "Skill Hub Initiative" in the institution to National Skill Development Corporation (NSDC), New Delhi. In response to this, NSDC sanctioned this project "Skill Hub Initiative" to the institution under PMKVY 4.0 scheme and accredited the institution to run this project for the year 2023.

The Skill Hubs would cover competency-based vocational training for the following target segments:

Under this project, a short – term training course namely "Self – Employed Tailor" was sanctioned for the year 2023. The NOS category of this course is "Apparel Made-Ups & Home Furnishing Sector Skill Council".

The institution invited applications from the target segments mentioned above, through socialmedia and print media. 30 candidates were enrolled and a batch was created to train the candidates. A separate lab was established with 15 sewing machines (5 sewing machines weredonated by an alumnus and 10 by a local NGO).

The training course was commenced on 6^h July, 2023 and ended on 22nd September, 2023 with 360 hours of duration (90 hours for Theory and 270 hours for practicals).

The attendance was marked for the candidates through AEBAS (Aadhar Enabled BiometricAttendance System) operated by NSDC, New Delhi.

After completion of this training programme, an assessment was conducted for 30candidates in the institution on 6^h July, 2023 by the assessment agency "IQAG".

Out of 30 candidates, who appeared for the assessment, 30 candidates got through the assessment and received certificates from the institution.
