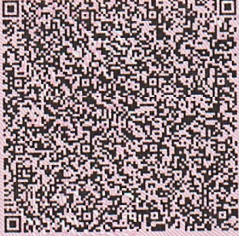

CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES

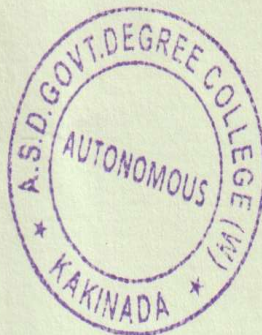
- It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
